- 3. CUSTOMER grants permission to AGENT to operate his/her vehicle in any manner it deems appropriate, including operation on and off a Mustang Chassis Dynamometer, and assumes full liability for loss or damage during said operation.
- 4. CUSTOMER agrees that AGENT is not responsible for any loss or damage to his/her vehicle or person as a result of the operation or tuning of the same. AGENT has made no representations other than those expressly made herein. No warranties or guarantees have been made to CUSTOMER who expressly acknowledge and understand the following:
 - a. Vehicles can and do suffer serious and catastrophic damage during or after operation on a Dynamometer. A Dynamometer pushes a vehicle and many mechanical components to critical levels which by its nature may cause failures of these components.
 - b. Automobiles are inherently unpredictable and unsafe, and operating or riding in a vehicle can lead to serious injury or death.
- 5. CUSTOMER agrees that all risks of loss or damage to his/her vehicle or person with regard to operation or tuning of his/her vehicle by AGENT or CUSTOMER remains with him/her.
